Code of Conduct for Competitors

Competitors are encouraged to abide by the following Code of Conduct (the "Code"). By choosing to compete in the AGFO Expo Chainsaw Speed Cutting Competition, you acknowledge and accept that the Code applies to you and that violation of the Code by you may be cause to disqualify you from the competition.

As a Competitor:

1. You will always compete according to the rules & regulations compiled by the SA Loggers Association.
2. You will never argue with an official.
3. You will control your temper.
4. You will be a good sport and applaud all competitors.
5. You will treat all players in your sport as you like to be treated.
6. You will display modesty in victory and graciousness in defeat.
7. You will participate for your own enjoyment and benefit.
8. You will not arrive at the venue intoxicated or drink alcohol at and during the competition.
9. You will respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion.
10. You will thank your opponents and officials at the end of the competition.

Please note

1. The Pro class competition is open to certified chainsaw operators only – please provide proof of certification
2. Each class is subject to 20 entries only
3. Each competitor must wear the appropriate PPE which include chainsaw pants
4. Competitors must at all time obey the safety instructions and should when instructed to do so immediately turn off the machine
5. All potential competitors must have their application forms completed at least 20 min before the start of the competition and report to the applicable arena.
6. Entry to the competition is free subject to entrants paying the applicable gate fee.
7. Each participant agrees to the terms and conditions contained in this document by signature hereunder.

Disclosure of Physical Condition

You agree to disclose to us all relevant personal health and fitness information both prior to and during engagement in the competition. You further warrant and represent that you will not participate in the competition whilst you are suffering from any serious injuries, infections or contagious illness, disease or other ailment or whilst you are suffering from any physical ailment such as open cuts or sores or minor infections where there is a risk, however small, to other competitors.

Waiver and Release of Liability

You (the "Competitor") understand that the activities/events in this competition include operating a chainsaw and may include, but are not limited to, physical activity which can cause physical injury or even death. You hereby freely and voluntarily, without duress, execute this Release under the following terms:

- A. **Waiver and Release.** You release and hold harmless the AGFO Expo 2017 Chainsaw Cutting Competition and its affiliated event organisers, successors and assigns from any liability, claims and demands of whatever kind or nature, either in law or in equity, which arise from competing in the competition. You understand and acknowledge that this Release discharges AGFO Expo (Pty) Ltd from any liability or claim that you may have with respect to any bodily injury, personal injury, illness, death or property damage that may result from your participation in this competition. You also understand that AGFO Expo and any other sponsor to the event and competition does not assume any obligation to provide financial assistance or other assistance, including

but not limited to medical, health, or disability insurance, in the event of injury, illness, death or property damage.

- B. **Medical Treatment.** You hereby release and forever discharge AGFO Expo and any other sponsor to the event and competition from any claim whatsoever which arises or may hereafter arise on account of any first aid treatment or other medical services rendered in connection with an emergency during this competition.
- C. **Assumption of the Risk.** You understand that competing in this competition may include activities that may be hazardous to you. You recognise and understand that such competitions involve inherently dangerous activities.. You hereby expressly and specifically assume the risk of injury or harm in these activities and release AGFO Expo and any other sponsor to the event and competition from all liability for injury, illness, death or property damage resulting from the competition.
- D. **Severability.** You expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Republic of South Africa, and that this Release shall be governed by and interpreted in accordance with the laws of the Republic of South Africa. You agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable. If we do not enforce our rights under this agreement at any time, it does not mean that we may not do so on future occasions. You warrant that the above details are true and agree to act sensibly to protect yourself and others from injury while participating in the competition. You also acknowledge that you understood and agree to the above Terms and Conditions.
- E. **By participating in the competition, I agree to being photographed and/or to be included in the filming of imagery recording the event and/or to be included in sound recordings of the event. I hereby waive any and all rights of publicity or privacy and hereby grant to AGFO Expo and any other sponsor to the event, the full and complete permission and authority to utilise my appearance in the event in all manners and media.**
